TEQBALL World Championships 2022 – Athlete support subsidy Call for Proposals

1. Objectives

The International Federation of TEQBALL (hereinafter referred to as FITEQ) the international body governing the sport of Teqball and federating all national Teqball entities, seeks to govern and promote the sport of Teqball not only through its own activities but also by governing and supporting the activities of such national federations as set forth in its Statutes.

FITEQ also recognizes its powers and importance in social responsibility matters and cannot ignore the special circumstances such as the Ukrainian war and the financial situation of third world countries.

Also, FITEQ wishes to promote the sport of Teqball by enriching the scale of participating nations and by providing the opportunity to enlarge the number of new participants at the TEQBALL World Championships 2022. To this end, FITEQ wishes to offer the opportunity to apply, in compliance with this call for proposal, for a subsidy to those athletes who qualified for the TEQBALL World Championships 2022 as per FITEQ rules.¹

2. Definitions

Applicant: the athlete qualified and registered to participate in the TEQBALL World Championships 2022.

Subsidy: the amount FITEQ pays as subsidy to the Applicants awarded with the subsidy

TF: national Teqball federation

3. Form and amount of the Subsidy

The amount of the Subsidy is limited. Please see the details below:

- 8 places granted to European athletes in an amount of EUR 300 / athlete
- 46 places granted to non-European athletes in an amount of EUR 600 / athlete

4. Submission criteria

This call is open to all Applicants that meet the following eligibility requirements:

1. Participated no more than once at previous Teqball World Championships; **or** special circumstances apply, that is i) if the Applicant is residing in and representing a county on the OECD's Development Assistance Committee's list²; **or** ii) if the Applicant is residing in or has left a country where an armed conflict or war is taking place; **and**
2. Commit to participate and does participate at the TEQBALL World Championships 2022; **and**
3. Commits to act ethically and comply with the applicable FITEQ Rules during the entire time of the TEQBALL World Championships 2022.

5. Submitting the Subsidy application

The application period commences on the date on the Effective date and ends on 27 October, 2022.

Applications may be submitted directly by the Applicant using the JOTFORM template under Annex 1 hereof made available separately.

¹ FITEQ may, upon its sole discretion, withdraw this call for proposals anytime without prior notice given to the Applicants. This, however, does not affect applications already approved by FITEQ.

6. Assessment criteria

Subject to the available places, and at the sole discretion of FITEQ, the Subsidy may be granted if the Applicant meets the eligibility criteria set out in Section 3 hereof.

7. Procedural rules

FITEQ's Sport Development Team, on behalf of FITEQ, will render its decision to provide the Subsidy within five (5) days from the submission of the application.

If the Subsidy is granted, a grant letter will be issued. If the Subsidy is not granted, such decision shall also be communicated such to the Subsidy holder within the deadline set herein.

In case FITEQ deems it necessary for the evaluation of the Subsidy, FITEQ may ask for evidence substantiating compliance with the special circumstances refereed to under point no. 1) of Section 3 – such evidence may include certificates related to a refugee status or a valid residence permit; Records relating to the participation in prior Teqball world championships or the lack thereof shall be taken into account by FITEQ automatically, no supporting evidence shall be required in that regard.

8. Permitted purposes

The Subsidy received must be used to cover the expenses incurred in connection with the participation in the TEQBALL World Championships 2022 only. Eligible expenditures may include: travel costs, accommodation costs, visa or similar border crossing-related costs.

FITEQ may request evidence supporting the compliant' use of the Subsidy anytime within 1 year following the TEQBALL World Championships 2022. In that event, the Athlete must provide the relevant invoices, bank certificates or booking confirmations or other relevant documents to FITEQ. Therefore, retaining after these documents after the event is required.

Winning Applicants must comply with all event and competition rules, including ethical conduct.

Applicants, who will have been found to breach the rules set out herein, shall be required to reimburse the amount of the Subsidy within eight (8) days following the written notice issued by FITEQ.

9. Timing and method of payment

9.1 FITEQ shall provide the amount of the Subsidy by bank transfer in line with this Section 9, but possibly no later than 10 workdays TEQBALL World Championships 2022 following the approval of the application. Exceptionally, FITEQ may decide to provide the amount of the Subsidy after the World Championships. In that event, FITEQ shall immediately inform the Applicant of such decision.

9.2 In order to determine the payment method of the Subsidy, the Applicant must declare on the application form whether or not it has received any support from the TF in connection with the Athlete's participation at the TEQBALL World Championships 2022. For the sake of clarity, Applicant warrants for the accuracy of the Applicant's declaration.

1) In case the Applicant declares that TF has already provided direct support to the Applicant for the WCH 2022 participation: Based on the Applicant's, request, FITEQ will transfer the Subsidy to the TF directly. Should the Applicant have received from the TF less than the Subsidy amount, the remaining amount, as evidenced by TF, shall be provided to the Applicant in full, without any deduction.

Under this option, TF and Applicant are responsible to conclude an agreement regarding the Subsidy payment to the Applicant. FITEQ's liability is expressly excluded for any and all claims arising from the agreement between the competent National Federation and the Applicant.

2) In case the Applicant did not receive TF support for the WCH 2022 participation, and the Applicant has a valid bank account registered with FITEQ and wishes to receive the Subsidy directly: Based on the Applicant's request, FITEQ will transfer the Subsidy to the bank account registered under the name of the awarded Applicant as specified in the application. For the sake of clarity, non-compliant bank account numbers will not be accepted.

3) In case the Applicant did not receive TF support for the WCH 2022 participation, and the Applicant does not have a valid bank account under his/her name and therefore wishes to receive the Subsidy through its TF: Based on the Applicant's request, FITEQ will transfer the Subsidy to the TF directly and the TF must give the full Subsidy amount to the Applicant without any deduction.

Under this option, TF and Applicant are responsible to conclude an agreement regarding the Subsidy payment to the Applicant. FITEQ's liability is excluded for any and all claims arising from the agreement between the competent TF and the Applicant.

4) In case the Applicant wishes to receive the Subsidy through and with the assistance of a TF to whom they are not affiliated, but who hosts them due to their special circumstances: Based on the Applicant's request, as agreed with the TF, FITEQ will transfer the Subsidy to the relevant TF.

Under this option, TF and Applicant are responsible to conclude an agreement regarding the Subsidy payment to the Applicant. The TF to whom the Applicant is not affiliated shall mean the federation in whose territory the Applicant is residing in case of armed conflict or war. FITEQ's liability is excluded for any and all claims arising from the agreement between the competent TF and the Applicant.

The TF shall provide the full amount of the Subsidy to the Applicant without any reductions or retention, except, if TF already provided subsidy to the Applicant regarding its participation of the TEQBALL World Championships 2022, in which case such amount, as evidenced by the TF, may be deducted.

10. Disputes and complaints

Applicant agrees and accepts that any complaint regarding the Subsidy shall be addressed solely to the Sport Director of FITEQ and any relating disputes shall be decided by the same as per FITEQ's relevant policies.

Any appeal against the Sport Director's decision shall be addressed to the Executive Board of FITEQ whose decision shall be final and binding.
